SARS-CoV-2 NOTICE **PURSUANT TO ARTICLE 13 OF THE EUROPEAN REGULATION 2016/679**

This document has been specially drawn up in order to inform you about the processing of your personal data. Pursuant to European Regulation 2016/679 (hereinafter referred to as: "GDPR"), you are provided with the following information.

The holder of personal data- as defined pursuant to Article 4, par. 1, no. 7) of the GDPR is the Organizer of the test / training / competition (indicated before as the "holder").

For everything concerning the processing of your data as well as the exercise of your rights, you can contact the Data Controller at the following e-mail address:

1. PURPOSE OF THE TREATMENT AND LEGAL BASIS

The personal data you provide are processed by the Data Controller exclusively to reduce the risk and prevent infection from SARS-CoV-2. The legal basis of the processing is the need to fulfill legal obligations to which the Data Controller is subject, as provided for in accordance with art. 6, letter c) of the GDPR, in relation to the implementation of anti-contagion security protocols.

Considering that, to access the Owner's premissions, is necessary a declaration from you by virtue of which you certify that you are not subjected to the quarantine measure, that you do not have Covid-19 (Coronavirus disease), that you don't have or don't have had in the last 5 days a body temperature above 37.5 °, or not have or not have had in the last 5 days one of the other symptoms, namely: (i) strong decrease in taste (flavors), (ii) severe decreased sense of smell (smells), (iii) dry cough, (iv) breathing difficulties, (v) severe exhaustion, (vi) nasal congestion, (vii) headache, (viii) diarrhea, or not have been in contact with Coronavirus positive people in the previous 14 days, or with their family members even if they are asymptomatic, your refusal to issue this declaration implies the impossibility for the Holder to comply with legal obligations and, consequently, the impossibility to access at the competition area.

It is specified that the data relating to body temperature detected in real time will not be recorded unless the temperature threshold is exceeded and in any case only if it is necessary to document the reasons that prevented access to the premises.

2. METHOD OF TREATMENT AND STORAGE TIME

We inform you that the processing of your data is carried out in compliance with the GDPR and the current regulatory provisions regarding the processing of personal data. We inform you that the treatment in question is based on the principles established pursuant to article 5 of the GDPR, in particular on the principles of correctness, lawfulness, transparency and protection of confidentiality and rights of the subject whose data are treated. Your personal data will be processed using paper, IT and telematic tools, with methods suitable for ensuring their security and confidentiality in accordance with the provisions of Article 32 of the GDPR. We inform you that your data will be processed for the period strictly necessary to achieve the purposes for which they were collected, specified in the previous point 1.



In particular, any personal data collected on the basis of this information will be kept by the Data Controller until the end of the emergency decreed at national or local level as a result of the spread of COVID-19.

In any case, once the state of emergency has ceased, any personal data stored by the Holder pursuant to this information will be deleted by the Holder.

3. COMMUNICATION OF YOUR PERSONAL DATA

Your personal data collected by the Data Controller will not be communicated or disclosed to third parties, except in the case in which the Data Controller is bound by specific regulatory provisions.

4. TRANSFER TO THIRD COUNTRIES

Your personal data will neither be transferred or stored to third countries.

5. RIGHTS OF THE INTERESTED

Pursuant to Article 7 co. 3 of the GDPR, we inform you that you can revoke the consent given at any time without prejudice to the lawfulness of the treatment based on the consent given prior to the revocation.

We also inform you that by submitting the request directly to the registered office of the Holder indicated above. You can exercise, at any time, pursuant to articles 15 to 22 of the GDPR, the right to:

- 1) ask for confirmation of the existence or otherwise of your personal data;
- 2) obtain information about the purposes of the processing, the categories of personal data, the recipients or categories of recipients to whom your personal data have been or will be communicated and, when possible, the retention period;
- 3) obtain the correction and cancellation of your personal data;
- 4) obtain the limitation of the processing of your data;
- 5) obtain data portability, i.e. receive them from a data controller, in a structured format, commonly used and readable by an automatic device, and transmit them to another data controller without impediments;
- 6) oppose the processing at any time and also in the case of processing for direct marketing purposes;
- 7) oppose an automated decision-making process relating to natural persons;
- 8) ask the Data Controller to access the data and to correct or delete them or limit their processing or to oppose their processing, in addition to the right to data portability; lodge a complaint with a supervisory authority.
